The Sibley County Board of Commissioners convened in the Commissioner's Room in the Courthouse in the City of Gaylord, MN on Tuesday, August 22, 2017 at 9:00 a.m. pursuant to notice given as required by law. The meeting was called to order by Commissioner Kruggel and began with the Pledge of Allegiance.
