## County of Sibley Regular County Board Proceedings Tuesday, October 10, 2017

The Sibley County Board of Commissioners convened in the Commissioner's Room in the Courthouse in the City of Gaylord, MN on Tuesday, October 10, 2017 at 9:00 a.m. pursuant to notice given as required by law. Members of the Board present: Commissioners Joy Cohrs, Bobbie Harder, Gary Kruggel, Bill Pinske and Jim Swanson. Also present were Roxy Traxler, Administrator and David E. Schauer, County Attorney.

The meeting was called to order by Commissioner Kruggel and began with the Pledge of Allegiance.

A motion was made by Commissioner Swanson, seconded by Commissioner Pinske and carried to approve the agenda as revised: Move Item 4.H. to 5.B.; Move Item 10.B. to 7.C.; Add Item 10.C. CHS services discussion

A motion was made by Commissioner Pinske, seconded by Commissioner Swanson and carried to approve the purchase of cell phone data extraction software from Cellebrite, Inc., Parsippany, NJ at a cost of \$12,935.00.

A motion was made by Commissioner Harder, seconded by Commissioner Kruggel and carried to approve the purchase of two 2018 Ford Explorer squads from Chuck Spaeth Ford, New Ulm, MN at a cost of \$26,782 each.

The County Board briefly discussed the fiscal responsibility of Sibley County Sheriff Posse services provided during the Sibley County Fair. Commissioner Kruggel will contact the County Sheriff and Fair Board President for additional information.

A motion was made by Commissioner Cohrs, seconded by Commissioner Harder and carried to approve Resolution #2017-49 Opposing Integration of Meeker-McLeod-Sibley Community Health Services.
